Instructions for Authors

Preparing and submitting your manuscript

Before preparing your submission, please visit the *Contemporary Arab Affairs* homepage at www.tandfonline.com/rcaa for full instructions for authors, including a complete style guide.

Submitted manuscripts are subject to peer review at the discretion of the Editorial Office. In order to maintain anonymity during any refereeing process, authors are requested to refrain from, or keep to a minimum, self-referencing.

Papers accepted become the copyright of the Journal, unless otherwise specifically agreed.

There are no page charges in *Contemporary Arab Affairs*.

Contributors should bear in mind that they are addressing an international audience. Manuscripts that do not conform to the requirements listed below will not be considered for publication or returned to their authors. Submissions will be seen anonymously by two referees.

Manuscripts should be sent to the Editor, Contemporary Arab Affairs, Centre for Arab Unity Studies, Beit Al-Nahda Building, Basra Street, Hamra, Beirut 2034 2407, Lebanon (email: info@caus.org.lb). Please make sure that your contact details are clearly visible on the outside of all packages you send to the editorial office. Articles should bear the title of the contribution, name(s) of the author(s) and the address where the work was carried out. Contributions should be in English but where short phrases or quotations are given in the original language they should be accompanied by a Roman transliteration, the United States Library of Congress schemes being used wherever possible. Each article should be accompanied by an abstract of 100–150 words on a separate sheet, and a short note of biographical details. The full postal address of the author should be included. All pages should be numbered. Articles should not exceed 5,000 words. Footnotes to the text should be avoided wherever possible.

Tables and captions to illustrations. Tables must be typed out on separate sheets and not included as part of the text. The captions to illustrations should be gathered together and also typed out on a separate sheet. Tables and figures should be numbered sequentially and referred to in the text. Captions should include keys to symbols.

Figures. Figures should be submitted in electronic format, as JPG, TIF or GIF files. Pictorial illustrations must be at a resolution of no less than 300 dpi/ppi and line diagrams at a resolution of no less than 120 dpi/ppi.

References should be indicated in the typescript by giving the author's name, with the year of publication in parentheses. If several papers by the same author and from the same year are cited, a, b, c, etc. should be put after the year of publication. The references should be listed in full at the end of the paper in Harvard format.
