CONTRIBUTORS

DANIEL P. ALDRICH is director of the Security and Resilience Studies Program and professor of political science and public policy at Northeastern University. He received a PhD and MA from Harvard University, an MA from the University of California at Berkeley, and a BA from the University of North Carolina at Chapel Hill. He has published five books and more than sixty-five peer-reviewed articles and has received awards from the National Science Foundation and the Abe Foundation, among others. He is currently working on a project focused on the role of social infrastructure in handling global problems such as extreme weather events, crime, and terrorism.

STEPHEN R. DUNCAN is an associate professor in the department of history at Bronx Community College-CUNY. He specializes in U.S. intellectual and cultural history, with research that examines

the intersections of culture and politics in the twentieth century. This includes attention to the civil rights movement, American empire, gender and sexuality studies, and film history. His first monograph, *The Rebel Cafe: Sex, Race, and Politics in Cold War America's Nightclub Underground*, was published by Johns Hopkins University Press in 2018. Also in 2018, he published the chapter on Social and Cultural History in *The Routledge History of the Twentieth Century United States*. In 2014, he published "Not Just Born Yesterday: Judy Holliday, the Red Scare, and the (Miss-)Uses of Hollywood's 'Dumb Blonde' Image," as a chapter in Laura M. D'Amore's collection, *Representing Women's Intellect in Film and Television*; and "Bohemian Rhapsodies: Sylvanus Cadwallader, Ulysses S. Grant, and Civil War Journalism" in *A Press Divided: Newspaper Coverage of the Civil War*, edited by David B. Sachsman. Dr. Duncan received his PhD in 2014 from the University of Maryland, where he was awarded the Walter Rundell Dissertation Prize for United States History. He was also awarded the University of the Pacific's Dave Brubeck Papers Research Fellowship in 2012.

MARGARETHE EIRENSCHMALZ works as a librarian and is pursuing a PhD at the University of Nevada, Reno, studying landscape history. Her research is focused on landscapes that have been dismissed as worthless and modified to meet human rather than ecological purposes.

CHRISTIAN FILBRUN is the Harry Reid Doctoral Fellow at the University of Nevada, Reno.

PHILIP GARONE is professor and chair of the Department of History at California State University Stanislaus. He earned a PhD in history and an MS in ecology from the University of California Davis, and his research has focused on the environmental history of the Central Valley and the Sacramento–San Joaquin Delta. He is the author of *The Fall and Rise of the Wetlands of California's Great Central Valley* (2011; paperback released in 2020) and is currently working on an environmental history of the terminal lakes of the western Great Basin.

ELWING SUONG GONZALEZ is an educator and historian who focuses on Los Angeles immigrant and refugee histories. She has taught in public secondary school for over fifteen years and teaches history at Rio Hondo College. She has a degree in Ethnic Studies from UC Berkeley, and master's and doctorate degrees in history from California State University, Los Angeles, and Claremont Graduate University. She has published articles on demographic changes and Vietnamese community placemaking in Los Angeles. She is currently working on histories of the role of mutual aid associations and community organizations in immigrant and refugee settlement in Los Angeles.

ROWENA GRAY is an economic historian who researches crime, housing markets, and technological change over the course of American history. She works at the University of California at

Merced, and earned a PhD in economics at the University of California, Davis. She is now working on her first book, on housing affordability in New York City.

SARAH M. GRIFFITH earned her PhD from the University of California, Santa Barbara, and is an associate professor in the Department of History at Queens University of Charlotte. Her research has appeared in the *Journal of American History* and the *Western Historical Quarterly*; in 2018 she published her first book, *The Fight for Asian American Civil Rights: Liberal Protestant Activism, 1900–1950*. In 2019, she was awarded a Fulbright Scholars fellowship in Japan, where she conducted research for a forthcoming study on the social and organizational networks forged between Japanese and American Christian women in the early twentieth-century Pacific.

LINDA IVEY is a professor of history at California State University, East Bay. She earned her PhD in environmental history at Georgetown University. She is coauthor, with Kevin Kaatz, of *Documents of the Japanese Internment: Eyewitness to History* (2020) and *Citizen Internees: A Second Look at Race and Citizenship in Japanese American Internment Camps* (2017). She has also authored “Ethnicity in the Land: Lost Stories in California Agriculture” (*Agricultural History*, 2007); “Apples and Experts: Evolving Notions of Sustainable Agriculture” (*Global Environment*, 2014); “Protecting the People’s Mountain: Hiking and the Roots of Environmentalism in Marin County,” in *Sports in the Bay Area: Golden Gate Athletics, Recreation and Community* (2017); and “Riotous Environments: Filipino Immigrants in the Fields of California,” in *An Environmental History of Modern Migrations* (2017). She is currently working on a history of forced migrations in the United States.

GAVIN JONES is the Frederick P. Rehmus Family Professor of the Humanities at Stanford University, where he teaches American literature. He is the author of four books, including *Reclaiming John Steinbeck: Writing for the Future of Humanity* (2021).

SARAH KEYES is assistant professor of history at the University of Nevada, Reno. She earned her BA from Pomona College in 2004 and her PhD from the University of Southern California in 2012. A specialist in the history of the U.S. West and the environment, she has received fellowships from numerous institutions, including the Radcliffe Institute for Advanced Study at Harvard University, the American Council of Learned Societies, and the Mellon Foundation. In 2008 she received the Louis Pelzer Memorial Award from the Organization of American Historians for the best essay written by a graduate student. Her recent publications in academic journals include “From Stories to Salt Cairns: Uncovering Indigenous Influence in the Formative Years of the Oregon Historical Society, 1898–1905,” *Oregon Historical Quarterly*; “Western Adventurers and Male Nurses: Indians, Cholera, and Masculinity in Overland Trail Narratives,” *Western Historical Quarterly*; and “‘Like a Roaring Lion’: The Overland Trail as a Sonic Conquest,” *Journal of American*

History. She has also contributed her expertise to the *Washington Post*, Nevada Humanities, C-SPAN's *American History TV*, and A&E Network's History Channel.

MORAMAY LÓPEZ-ALONSO, associate professor of history at Rice University, is an economic historian of Latin America who earned her PhD at Stanford University. Her research focuses on the history of inequality. Her published works include *Measuring Up: A History of Living Standards in Mexico, 1850–1950* (2012), winner of the 2013 Mexican History Book Prize awarded by the Conference on Latin American History. She is currently working on day-care provision in twentieth-century Mexico and its implications for working women's participation in political and economic life.

LAURA MEACHAM is a graduate student in historical studies at the University of Nevada, Reno. Her focus is on Nevada and the U.S. West, and she hopes to complete her degree in spring 2022.

ENRIQUE A. SANABRIA is associate professor of modern European history at the University of New Mexico, with a specialty in the modern political and cultural history of Spain. He is the author of *Republicanism and Anticlerical Nationalism in Spain* (New York: Palgrave Macmillan, 2009) and is currently working on a cultural and ecological history of the Manzanares River in Madrid.

KHAL SCHNEIDER is associate professor of history at California State University, Sacramento. His articles on California Indian history have appeared in several journals, most recently *The Public Historian*.

SARAH SCHRANK is professor of history at California State University, Long Beach. She earned her PhD from the University of California, San Diego. She is the author of *Art and the City: Civic Imagination and Cultural Authority in Los Angeles* (2009) and *Free and Natural: Nudity and the American Cult of the Body* (2019). She is currently working on a book manuscript on the gendered history of wellness in the United States.

MARC STEIN is the Jamie and Phyllis Pasker Professor of History at San Francisco State University, where he teaches courses on constitutional law, social movements, and the history of sexuality. He earned a BA in history at Wesleyan University (Connecticut) and a PhD in history at the University of Pennsylvania. He is the author of *City of Sisterly and Brotherly Loves: Lesbian and Gay Philadelphia, 1945–1972* (University of Chicago Press, 2000); *Sexual Injustice: Supreme Court Decisions from Griswold to Roe* (University of North Carolina Press, 2010); *Rethinking the Gay and Lesbian Movement* (Routledge, 2012); and *The Stonewall Riots: A Documentary History* (NYU Press, 2019). He also served as editor-in-chief of the award-winning *Encyclopedia of LGBT History in America* (Scribners, 2003) and as guest editor of "U.S. Homophile Internationalism," a special issue of the *Journal of Homosexuality* (2017). He is currently the coeditor of *Queer Pasts*, a digital history project published by Alexander Street/ProQuest. He has been awarded the Gregory Sprague

Prize and Audre Lorde Prize by the Committee on LGBT History (1996 and 2006) and the Graduate Teaching Award by York University (2010). In 2022 the University of California Press will publish his next book, *Queer Public History: Essays on Scholarly Activism*, and Routledge will publish a second edition of *Rethinking the Gay and Lesbian Movement*.

YUJI SUGIMOTO graduated from Stanford University in 2019 with a BS in Electrical Engineering. He is currently employed at Astranis as an avionics engineer. This essay stems from a senior research project completed in spring 2019 at Stanford University, in Professor Carol McKibben's class "Minority-Majority Cities in California."
