Notes on Contributors

DAVID C. ATHERTON is associate professor of East Asian Languages and Civilizations at Harvard University and the author of *Writing Violence: The Politics of Form in Early Modern Japanese Literature* (Columbia, 2023). He is currently writing a book about authorship and conceptions of literary creativity in the early modern period.

E. TAYLOR ATKINS is Distinguished Teaching Professor of History at Northern Illinois University. His most recent books are *Kogun by the Toshiko Akiyoshi-Lew Tabackin Big Band* (Bloomsbury, 2024) and *A History of Popular Culture in Japan, From the Seventeenth Century to the Present* (second edition, 2022).

EUGENIA BOGDANOVA-KUMMER is an associate professor in Japanese Arts, Culture, and Heritage at the Sainsbury Institute for the Study of Japanese Arts and Cultures, affiliated to the University of East Anglia. Her research interests include postwar art in Japan, modern calligraphy history in East Asia, transcultural studies, abstract art, and the relationship between image and language in modern Japan. She is the author of *Bokujinkai: Japanese Calligraphy and the Postwar Avant-Garde (Japanese Visual Culture Series, 19, Leiden and Boston: Brill, 2020)* and is currently working on her second book project on the history of calligraphy modernization in East Asia.

W. PUCK BRECHER is professor of Japanese History at Washington State University. He is the author of *Loving and Loathing Wildlife in Japan: Four Animal Conservation Paradigms* (University of Hawai'i Press, 2025), *Animal Care in Japanese Tradition: A Short History* (Association for Asian Studies, 2022), *Japan's Private Spheres: Autonomy in Japanese History, 1600–1930* (Brill, 2021), *Honored and Dishonored Guests: Westerners in Wartime Japan* (Harvard University Asia Center, 2017), and *The Aesthetics of Strangeness: Eccentricity and Madness in Early Modern Japan* (University of Hawai'i Press, 2013). He is also coeditor of *Defamiliarizing Japan's Asia-Pacific War* (University of Hawai'i Press, 2019).

KIRSTEN CATHER is an associate professor in the Department of Asian Studies at the University of Texas at Austin. Her first book, *The Art of Censorship in Postwar Japan* (University of Hawai'i Press, 2012) analyzed landmark censorship trials of “obscene” (*waisetsu*) literature, films, photography, and manga. Her most recent monograph, *Scripting Suicide in*

Japan (University of California Press, October 2024), considers how and why individuals write and read in the face and wake of suicide.

ANNIKA A. CULVER is professor of East Asian History at Florida State University and belongs to the U.S.-Japan Network for the Future. She also curates the Oliver L. Austin Photographic Collection, a digital archive of 1,000 images of postwar Japan. Professor Culver is currently writing *American Daimyō: The Story of a Transoceanic Japanese American Noble Family*, on contract with University of Hawai'i Press. Besides *Democratizing Luxury: Name Brands, Advertising, and Consumption in Modern Japan* (2023), she has published three other books: *Japan's Empire of Birds* (2022), *Glorify the Empire* (2013), and the coedited volume *Manchukuo Perspectives* (2019).

RACHEL DiNITTO is professor of Japanese Literature at the University of Oregon and researches the nuclear environmental humanities through contemporary cultural production including literature, film, and manga. Her book *Fukushima Fiction: The Literary Landscape of Japan's Triple Disaster* (2019) was a winner of the Choice Magazine Outstanding Academic Title. See her research on Japanese film in her new edited volume, *Eco-Disasters in Japanese Cinema* (2024), and chapters and articles in *The Japanese Cinema Book*, *Japan Forum*, *Journal of Japanese Studies*, and *The Asia-Pacific Journal*.

ANDREW ELLIOTT is professor at the Faculty of Liberal Arts, Doshisha Women's College, Kyoto. His current research focuses on international tourism in the Japanese empire and the representation of cross-cultural encounters between Japan and the West from the bakumatsu period in travel writing and other forms of popular culture. Publications include a coedited special edition of *Japan Review* on tourism and war (2019), "Mutual Interests: Pacific Expansionism and the Reception History of Townsend Harris in Japan and America, 1856–1959" in *Pacific Gateways: Trans-Oceanic Narratives and Anglophone Literature, 1780–1914* (Palgrave Macmillan, 2024), and a chapter on the development of inbound tourism in Japan, 1890–1940, in the *Oxford Handbook of Tourism History* (forthcoming, 2025).

ANDREA GERMER is professor of Japanese studies at Heinrich Heine University Düsseldorf. Her field of teaching and research includes gender and animation, historical visual propaganda, and fascism. Major publications are *Gender, Nation and State in Modern Japan* (coedited with V. Mackie and U. Wöhr, Routledge, 2014), *Historische Frauenforschung in Japan* [Women's History in Japan] (Iudicium, 2003), and several

articles on the history of women's movements and gender in Japanese animation. She recently coedited the volumes *Handbook of Feminism in Japan* (with U. Wöhr, Japan Documents, 2024) and *Gendering Fascism: Individual Actors, Concepts, and Transnational Connections* (with J. Rückert, Brill, 2025).

TOM GILL is a British Professor of Social Anthropology at the Faculty of International Studies at the Yokohama campus of Meiji Gakuin University. His research covers casual labor, homelessness, and victims of the Fukushima Nuclear Disaster. Other academic interests include gambling, alcoholism, folklore, and *gekiga* manga, particularly those of Tsuge Yoshiharu. Publications include *Japan Copes with Calamity: Ethnographies of the Earthquake, Tsunami and Nuclear Disasters of March 2011* (Peter Lang, 2013; coeditor), and *Yokohama Street Life: The Precarious Career of a Japanese Day Laborer* (Lexington, 2015).

CAROLINE HIRASAWA is an associate professor at Waseda University. Her current research is on medieval illustrated handscrolls that promote Buddhist rituals and their transcendent effects.

DANIEL JOHNSON is assistant professor of Japanese Studies in the Department of Modern Languages and Literatures at the College of William and Mary. His book *Textual Cacophony: Online Video and Anonymity in Japan*, was published in 2023 by Cornell University Press. He is putting the finishing touches on a book about Japanese video games in the 1990s that focuses on technology and animation, tentatively titled *Playing with Animation*.

WILLIAM W. KELLY is professor emeritus of anthropology at Yale University and author, most recently, of "Baseball: Japan's National Pastime," in Helen MacNaughton and Verity Postlewaite, editors, *Handbook of Sport and Japan* (MHM Limited, 2024).

VICTORIA LEE is an associate professor of history at Ohio University. She is the author of *The Arts of the Microbial World: Fermentation Science in Twentieth-Century Japan* (Chicago, 2021), which was awarded the 2023 International Convention of Asia Scholars Book Prize for the Best Book in the Humanities. She is currently exploring how the twentieth-century history of agroindustrial science offers precedents for approaching questions of sustainability in the twenty-first century.

KATE McDONALD is associate professor of Modern Japanese History at the University of California, Santa Barbara. She is the author of *Placing*

Empire: Travel and the Social Imagination in Imperial Japan (University of California Press, 2017), codirector of the digital *Bodies and Structures: Deep-Mapping Modern East Asian History* project, and coeditor of the monograph series *Johns Hopkins Studies in the History of Technology*.

SCOTT NORTH is professor emeritus of sociology in the Graduate School of Human Sciences and Director of the North American Center for Academic Initiatives at Osaka University.

HARUMI OSAKI received her PhD in East Asian Studies from McGill University in 2016. She is currently an adjunct lecturer at Chukyo University and Nagoya University, Japan. Her main areas of research are Japanese philosophy and wartime thoughts. Among her works are *Nothingness in the Heart of Empire: The Moral and Political Philosophy of the Kyoto School in Imperial Japan* (2019), “A Comparison of Watsuji’s *Fūdo* and Deleuze and Guattari’s *A Thousand Plateaus*: Questioning an Equivalence between Japaneseness and Postmodernity” (2022), and “The Dialectic of Hegel and Nishida: How to Deal with Modernity” (2017).

CATHERINE L. PHIPPS is Dunavant Associate Professor of History at the University of Memphis. Her publications include *Empires on the Waterfront: Japan’s Ports and Power, 1858–1899* (Harvard University Asia Center, 2015), *Meiji Japan in Global History* (Routledge, 2022), and “Mobility in an Age of Imperialism, Nation-Building, and Revolution: Kawata Masazō’s Late-Nineteenth-Century Pacific World,” *Journal of World History* (2023). She is currently writing one book centering modern Japan in global history and one on Osaka’s shipping industry, especially local re-engineering and cultural re-invention of the city’s harborscape for modern industry and commercial empire in East Asia.

LUKE S. ROBERTS earned his PhD in East Asian Studies at Princeton University in 1991. He is author of *Mercantilism in a Japanese Domain* and *Performing the Great Peace*, and co-author with Sharon Takeda of *Japanese Fishermen’s Coats of Awaji Island*. He is currently doing research on samurai families and gender in the Edo period and is professor of history at the University of California, Santa Barbara.

MIRYAM SAS is Bernie H. Williams Chair in Comparative Literature and Japanese and Professor and Chair of the department of Film & Media at the University of California, Berkeley. She has written books and articles about Japanese experimental literature and arts including *Fault Lines: Cultural Memory and Japanese Surrealism* (Stanford University Press, 2001) and *Experimental Arts in Postwar Japan: Moments of Encounter*,

Engagement, and Imagined Return (Harvard University Asia Center, 2010). Her most recent book on media theory and intermedia art is *Feeling Media: Infrastructure, Potentiality, and the Afterlife of Art in Japan* (Duke University Press, 2022). She is working on a collaborative/archival memoir, *Finding Zbaraż*, and a book on questions of realism and blur in Japanese photography.

PETER SHAPINSKY is professor of history at the University of Illinois, Springfield. He is author of *Lords of the Sea: Pirates, Violence, and Commerce in Late Medieval Japan* (Center for Japanese Studies, University of Michigan, 2014), “Monks, Merchants, and Marauders,” forthcoming in the *New Cambridge History of Japan*, and other works.

CHRISTOPHER SMITH is an assistant professor of modern Japanese literature and culture at the University of Florida where he teaches courses on modern Japanese literature, culture, manga, and anime. His research focuses on postwar Japanese literature, particularly contemporary literature (Heisei-Reiwa), as well as Japanese pop culture, including manga and anime. He recently published a translation of Tanaka Yasuo’s *Somehow, Crystal* (Kurodahan Press). His first monograph, *Samurai with Telephones: Anachronism in Japanese Literature*, is available from the University Michigan Press.

TAKEYUKI (GAKU) TSUDA is a professor of anthropology in the School of Human Evolution and Social Change at Arizona State University. After receiving his PhD in anthropology in 1997 from the University of California at Berkeley, he was a collegiate assistant professor at the University of Chicago and then served as associate director of the Center for Comparative Immigration Studies at the University of California at San Diego. His primary academic interests include international migration, diasporas, ethnic minorities, ethnic and national identity, transnationalism and globalization, ethnic return migrants, the Japanese diaspora in the Americas, and mixed-race Asians in the U.S.

KÄREN WIGEN teaches Japanese history and directs the Mellon Fellowship of Scholars in the Humanities at Stanford University. Her recent projects include the collaborative volumes *Cartographic Japan, Time in Maps*, and *Territorial Imaginaries: Beyond the Sovereign Map* (University of Chicago Press).

CHRISTIAN G. WINKLER is a professor of political history at Seinan Gakuin University in Fukuoka. His main research interests are postwar intellectual history, particularly conservatism, and the constitutional amendment

debate. He is the author of *The Quest for Japan's New Constitution* (Routledge, 2011). His articles have been published in the *Journal of Japanese Studies*, *Social Science Japan Journal*, *Journal of East Asian Studies*, *Japan Forum*, *Asian Survey*, and *Asian Studies Review*.

SAMUEL H. YAMASHITA is the Henry E. Sheffield Professor at Pomona College, where he has taught since 1983. He was a specialist on early modern Japanese Confucianism before turning in the 1990s to the Asia Pacific War. Since 2009 he has been doing research on food and published *Hawai'i Regional Cuisine: The Food Movement That Changed the Way Hawai'i Eats* in 2019. He is currently finishing an anthology of the writings of Japanese kaiseki chefs, a study of the hyperlocal cuisines that appeared along the Pacific Rim in this century, and a history of Japanese food.

CHRISTINA YI is associate professor of Modern Japanese Literature at the University of British Columbia. Her first monograph, *Colonizing Language: Cultural Production and Language Politics in Modern Japan and Korea*, was published by Columbia University Press in 2018. She was also the coeditor for a special feature on Zainichi Korean literature and film for *Azalea: Journal of Korean Literature and Culture*, 12 (2019) as well as the edited volume *Passing, Posing, Persuasion: Cultural Production and Coloniality in Japan's East Asian Empire* (with Andre Haag and Catherine Ryu, 2023).
