ALAN FISCHLER is Professor of English at Le Moyne College in Syracuse, New York. He is the author of *Modified Rapture: Comedy in W. S. Gilbert's Savoy Operas* (1991) and of the chapter on Drama in the *Blackwell Companion to Victorian Literature and Culture*, edited by Herbert F. Tucker (1999). He has also published numerous articles on W. S. Gilbert and such nineteenth-century theater folk as Douglas Jerrold, J. R. Planché, Dion Boucicault, and Madame Vestris.

REBECCA N. MITCHELL, Assistant Professor of English at the University of Texas-Pan American, is the author of *Victorian Lessons in Empathy and Difference* (2011) as well as several essays on Victorian writers such as Charles Dickens, George Meredith, and George Eliot. She has coedited, with Criscillia Benford, a critical edition of Meredith's *Modern Love and Poems of the English Roadside, with Poems and Ballads*, forthcoming in 2012 from Yale University Press. Currently in progress is a book-length study that considers the figure of the genius in Victorian popular culture.

JOHN P. SCHLUETER is Professor of English at Harry S. Truman College. His essay "Beyond Reform: Agency 'After Theory'" appeared in *Feminist Theory: An International Interdisciplinary Journal* in 2007 and was reprinted in the reference collection *Structure and Agency*, as part of a series entitled *Key Debates in Sociology* (Sage Publications, 2010). Another essay, "The Art of Debate: Disagreement, Consensus, and Democratic Associations," appeared in *Soundings: An Interdisciplinary Journal* in 2009.

GEORGE YEATS is a Lecturer in English Literature at Regent's College, London. He is currently working on a series of articles on the Victorian reception of Shakespeare, including a forthcoming essay entitled "Shakespeare's Victorian Legacy: text as monument and emendation as desecration in the mid-nineteenth-century."



MARK J. BRUHN is Professor of English at Regis University. His essays on cognition and British Romanticism have appeared in *Poetics Today* (2005, 2009, 2011) and *Studies in Romanticism* (2006, 2009). He is currently guest-editing a special issue of *Poetics Today* on “Exchange Values: Poetics and Cognitive Science.”

CHRISTINE DEVINE, Associate Professor of English at the University of Louisiana at Lafayette, is the author of *Class in Turn-of-the-Century Novels of Gissing, James, Hardy and Wells* (2005) as well as essays published on George Gissing, Thomas Hardy, Henry James, Charles Dickens, and George Eliot. She edited Gissing’s *Abridgement of Forster’s Life of Dickens* for the *Complete Works of George Gissing on Charles Dickens* (2005), and is editor of the forthcoming *Nineteenth-Century British Travelers of the World*. Two coedited volumes are forthcoming: *Turning Points and Transformations: Essays on Literature, Language and Culture* and *North and South: Constructing/Crossing the Divide*.

ELIZABETH DUQUETTE, Associate Professor of English at Gettysburg College, is the author of *Loyal Subjects: Bands of Nation, Race, and Allegiance in Nineteenth-Century America* (2010). Her essay “Pierre’s Nominal Conversions” recently appeared in the collection *Melville and Aesthetics*, edited by Samuel Otter and Geoffrey Sanborn (2011).

JOE B. FULTON is Professor of English at Baylor University in Waco, Texas, where he has been honored as an “Outstanding Professor for Scholarship” and as a “Baylor University Class of 1945 Centennial Professor.” Dr. Fulton has published numerous books and articles on American literature. In addition, he has published four books on Mark Twain: *Mark Twain’s Ethical Realism: The Aesthetics of Race, Class, and Gender* (1997); *Mark Twain in the Margins: The Quarry Farm Marginalia and the Composition of “A Connecticut Yankee in King Arthur’s Court”* (2000); *The Reverend Mark Twain: Theological Burlesque, Form, and Content* (2006); and *The Reconstruction of Mark Twain: How a Confederate Bushwhacker became the Lincoln of our Literature* (2011), winner of the Jules and Frances Landry Award for Outstanding Achievement in the Field of Southern Studies.

AUDREY JAFFE, Professor of English at the University of Toronto, is the author of *The Affective Life of the Average Man: The Victorian Novel and the Stock-Market Graph* (2010) and an essay on Hardy's realism in *Novel*, 2010. She is currently working on a reconsideration of realist conventions in the Victorian novel.

NANCY AYCOCK METZ is Professor of English at Virginia Tech. She is the author of *The Companion to "Martin Chuzzlewit"* (2001) and articles about Dickens that have appeared in *The Dickensian*, *Dickens Studies Quarterly*, *Dickens Studies Annual*, *Victorian Studies*, and *Nineteenth-Century Fiction*. She is now working on an annual review of Dickens scholarship for 2010 for *Dickens Studies Annual* (to appear in 2012).

RICHARD C. SHA, Professor in the Department of Literature at American University, is the author of *The Visual and Verbal Sketch in British Romanticism* (1998) and *Perverse Romanticism: Aesthetics and Sexuality in Britain, 1750–1832* (2009). His current project is tentatively titled "Imagining the Imagination: Science and British Romanticism." He is coediting, with Joel Fatlak, a collection titled "Romanticism and the Emotions."

PHILIP E. SMITH II is Associate Professor of English at the University of Pittsburgh. He is editor of *Approaches to Teaching the Works of Oscar Wilde* (2008) and coauthor and coeditor, with Michael S. Helfand, of *Oscar Wilde's Oxford Notebooks: A Portrait of the Mind in the Making* (1989). He has published numerous essays on Wilde. He is now at work coediting, with Joseph Bristow, *Oscar Wilde's "Philosophy" Notebook and Related Humanistic Writings c. 1872–1879*, a fully annotated edition of Wilde's significant undergraduate and postgraduate notebooks.

SUSAN J. WOLFSON is Professor of English at Princeton University. Among her books she is the author of *Romantic Interactions: Social Being and the Turns of Literary Action* (2010), *Borderlines: The Shiftings of Gender in British Romanticism* (2006), and editor of *Felicia Hemans: Selected Poems, Letters, and Reception Materials* (2000). In progress is an edition of *The Annotated Frankenstein*, coedited with Ronald Levaio; and a critical study tentatively titled "Romantic Possessings."
