CHRISTOPHER NEWFIELD was Distinguished Professor of English at the University of California, Santa Barbara, and is now Director of Research at the Independent Social Research Foundation in London. He has written a trilogy of books on the university as an intellectual and social institution: *Ivy and Industry: Business and the Making of the American University, 1880–1980* (Duke, 2003); *Unmaking the Public University: The Forty-Year Assault on the Middle Class* (Harvard, 2008); and *The Great Mistake: How We Wrecked Public Universities and How We Can Fix Them* (Johns Hopkins, 2016). He is co-author of *What Metrics Matter? Academic Life in the Quantified University* (Johns Hopkins, 2023) and co-editor of *The Limits of the Numerical* (Chicago, 2022).

DUSTIN D. STEWART is Associate Professor of English and Comparative Literature at Columbia University. *Futures of Enlightenment Poetry*, his first book, was awarded the Louis Gottschalk Prize. A new project examines the Anglican parish as a socioecological form.

TOM CLAYTON is Assistant Professor in the Department of English and Creative Writing at Colgate University. His scholarship focuses on literature, religious difference, and the making of political concepts in seventeenth-century England. He is working on a book, titled *The Reformation of Indifference*, about the evolution of the Protestant doctrine of indifference (or *adiaphora*) in the period just before the emergence of the liberal rationale for religious toleration.

JENSEN SUTHER is a former Fulbright Scholar and received his PhD from Yale University. He is currently a Junior Fellow in the Harvard Society of Fellows. His writing has appeared or is forthcoming in a range of academic and public-facing venues, including *Modernism/modernity*, the *Hegel Bulletin*, the *Los Angeles Review of Books*, and the *New Statesman*. He is currently working on two books—*Spirit Disfigured* and *Hegel's Bio-Aesthetics*—which explore Hegel's legacy for Marxism in aesthetic, political, and philosophical contexts.

DEVIN WILLIAM DANIELS is Visiting Assistant Professor of Literatures in English at Bryn Mawr College. His research focuses on twentieth-century literature and film, information technology, and the state. His other work is published or forthcoming in *Mediations*, *English Studies in Africa*, *Contemporaries at Post45*, and *Hyped on Melancholy*.

ALEXANDER BIGMAN is an art historian and critic based in New York City. His first book, *Pictures and the Past: Media, Memory, and the Specter of Fascism in Postmodern Art*, is forthcoming from the University of Chicago Press.
