The Historical Society of Southern California was founded on November 1, 1883, and incorporated February 13, 1891. It has enjoyed an unbroken record of continuous activity and growth. Commencing in 1884, and each year through 1934, the society issued an *Annual Publication*. In 1935 *The Quarterly* (later renamed the *Southern California Quarterly*) was initiated. The Society's publications through 1976 have been indexed and described in a concise abstract of articles by Anna Marie and Everett Gordon Hager (comps.), *A Bibliography* (1958), *The Topical Index* (1959), and *Cumulative Index* (1977). The current issue and all back issues are available online to members of the Society (regular level and higher) and through subscribing libraries.

Warren C. Wood, Ph.D., is an Instructor in History at California Polytechnic University Pomona where he teaches US and California History. His research concerning fatherhood in the nineteenth-century American West led him to this study of the 1852 California State Census.

Stacey L. Smith is an Associate Professor of History at Oregon State University where she specializes in the history of the American West and the Civil War and Reconstruction eras. She is the author of *Freedom's Frontier: California and the Struggle over Unfree Labor, Emancipation, and Reconstruction* (University of North Carolina Press, 2013), which won the inaugural David Montgomery Prize in U.S. labor history from the Organization of American Historians and the Labor and Working-Class History Association. She is currently working on a book on African American abolitionists and civil rights activists in the Pacific West entitled an *Empire for Freedom*.

Kenneth H. Marcus is Professor of History at the University of La Verne. He holds a B.A. in history from UC Berkeley; an MBA from Ecole Supérieure de Commerce de Paris, France; and a Ph.D. in history from Cambridge University, UK. He has published three books, most recently *Schoenberg and Hollywood Modernism* (Cambridge University Press, 2016) as well as over fifty articles, book chapters, encyclopedia entries, and book reviews on subjects ranging from California cultural history to music patronage in early modern Germany. Among his media projects is a CD, *Some American Music*, featuring works by Scott Joplin, George Gershwin, Woody Guthrie, and Kenneth Marcus, for which he performed on piano and guitar.

ERRATA: A reader has brought to our attention an error in the Spring 2017 issue (Vol. 99, no. 1), pp. 74–75, in reference to the St. Francis Dam. Both powerhouses were constructed and operating some years BEFORE the dam and NEITHER used water from the dam's reservoir to produce power. Readers are referred to Paul H. Rippens, *Saint Francis Dam: A Guide to the Los Angeles Aqueduct and the Site of the Ill-Fated Saint Francis Dam* (Alhambra: Copy-Rite Press, 2003) and to Norris Hundley Jr. and Donald C. Jackson, *Heavy Ground: William Mulholland and the St. Francis Dam* (University of California Press, 2015), 27, 39–42. A typo in the Fall 2017 issue (Vol. 99, no. 3), p. 346, dates the collapse of the St. Francis Dam in March 1927; it failed in March 1928.
